#### DESCRIPTION

Tile Guard #99xx series is a quality, gloss latex, roof paint which provides good hiding, uniform coverage, ease of application, and holds up well in the Sunbelt climate. This product is especially formulated for use on unglazed concrete tile, masonry shingle or properly primed metal roofs. It is treated with fungicide to resist mildew growth and discoloration of the paint film. It's gloss finish helps keep roofs looking freshly painted longer.

#### SURFACE PREPARATION

To insure a good bond to a sound substrate. All dust, dirt, soot, grease, calcium or salt film, loose sand or gravel, fungus, mildew, algae or other contamination must be removed. Previously applied paints which have deteriorated through age, and are powdering, chalking, flaking, peeling or blistering, must also be removed. The surface condition determines which cleaning method is required - washing, scraping, wire brushing, pressure cleaning or a combination may be required. Apply a chlorine solution with a pressure cleaner or auxiliary sprayer to kill mildew or fungus spores. Rinse thoroughly. Prime bare metal with Anvil's #1606 rust inhibitive primer or a quality acrylic rust encapsulating primer.

#### APPLICATION

Use brush, roller or spray to apply. Best results are obtained when using airless spray equipment. Two thin, uniform coats of paint will out-perform one heavy coat. Mix thoroughly prior to use. When working with more then one can of the same product, inter-mix to ensure color uniformity. Painted surface must be maintained by cleaning periodically with a mild chlorine solution. Do not apply in direct sunlight. All roof surfaces must be dry. Apply starting at the top of the roof and working down. Caution: Roof surfaces may become extremely slippery when wet.
